ASSUMPTION OF RISK, LIABILITY RELEASE, AND INDEMNITY AGREEMENT:

IMPORTANT: READ THE FOLLOWING CAREFULLY. WHEN YOU SIGN IT YOU WILL BE GIVING UP

IMPORTANT LEGAL RIGHTS.

In consideration of City of Las Vegas, MARUNDE agreeing to permit me to participate in the Strongman Challenge, and for other good and valuable consideration including, but not limited to, promotion of extreme sport of the Strongman Challenge, in which I am a participant and by participating in which I stand to gain economically. I, undersigned participant, acknowledge and agree to be bound by the following:

1. Identification of Inherent risks. As a professional participant in the Strongman Challenge, which is sponsored by HKPK, and MARUNDE, I, the undersigned understand that I am undertaking an extreme sport, which not only possibly, but likely will result in injury to me. I am a professional participant in this competition, and I understand that may or may not regularly engage in holding and HKPK, and MARUNDE, promoting professional extreme sporting competitions. In other words, I know as much or more about the extreme sport in which I will participate, and the risks of injury or death presented by it than do HKPK and MARUNDE. The risks of injury and death include, but are not limited to, death by crushing by falling heavy object or other means, impact, falling, asphyxiation, hemorrhage or unforeseen medical condition exacerbated or triggered by extreme stress generated by my participation in this event. There is further risk of injury, including broken, dislocated or fractured spine, bones, torn, pulled, strained or sprained muscles, tendons, ligaments or other soft tissue, spinal, nerve, limb, finger, toe or internal organ damage due to the strains and stresses of participating in this competition and the heavy objects employed in it. I recognize that contestants in strongman competitions such as this one often are forced to drop out of the competition due to injuries, and that they are responsible for determining for themselves whether they are too injured to proceed. I take responsibility for ensuring

that I do not exceed my own limits and cause or exacerbate any injury to myself. I understand that I am participating in an EXTREME SPORT in which I could be injured or killed, and I accept that risk! I also understand that despite their use of reasonable care, HKPK, and MARUNDE cannot ensure my safety during my participation in this event, because of its extreme nature. The risks presented by the event are unavoidable given its nature as an extreme sport. I understand that I am participating in an extreme sport, that it may cause me injury or I may be killed, and I take responsibility for ensuring my own safety in my participation in the event.

2. Assumption of Risk. I, the undersigned, am aware of and appreciate the risks associated with my participation in the Strongman Challenge. I know them as well or better than HKPK, and MARUNDE because I am a professional participant in this event. I understand that the risks of my participation include serious injury or death, including those risks set forth above in paragraph 1. I agree that I am responsible for my own safety in participating in this event, and that I am physically and psychologically prepared to participate in the event. I understand that my safety in the event has not been guaranteed by HKPK, and MARUNDE. I acknowledge that I must be responsible for preventing injury to myself and that I must perform within my own limits, which only I know. The undersigned participant understands that the inherent risks associated with the Activity include, but are not limited to, suffering bodily injury by participating in the Strongman Challenge.

3. Liability Release. I, \_\_\_\_\_(print your name), hereby WAIVE, RELEASE, DISCHARGE AND AGREE TO HOLD HARMLESS, HKPK, and MARUNDE, their officers, directors, shareholders, partners, employees, agents, representatives and subcontractors or affiliates from any and all claims and/or liability, whether known or unknown, in any way connected with my participation in the Activity even though such claim and/or liability may arise out of negligence or carelessness on the part of the Released Parties. I intend for this LIABILITY RELEASE AND WAIVER to also apply to any relatives, personal representatives, heirs, beneficiaries, next of kin or assigns who might pursue any legal action or claim on my behalf.

4. Indemnity Agreement. I willingly and knowingly agree that the purpose and intent of this indemnity agreement is to allocate the risks stemming from the Activity to me, even though these risks may be increased due to the negligence of the Indemnified Parties. I HAVE READ THIS ASSUMPTION OF RISK, LIABILITY RELEASE, AND INDEMNITY AGREEMENT CAREFULLY AND UNDERSTAND ITS TERMS FULLY AND COMPLETELY AND AGREE TO BE BOUND BY THEM.
